

**SYDNEY COMEDY STORE PRIVATE PERFORMANCE COMPETITION**  
**Terms and Conditions**

1. Information on how to enter and the prize/s form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is HCF – The Hospitals Contribution Fund of Australia Ltd of HCF House, 403 George Street, Sydney, NSW 2000 (ABN 68 000 026 746). The promotion will be judged and the prizes allocated by The Hospitals Contribution Fund of Australia Ltd (ABN 68 000 026 746) (**HCF**).
3. Entry is only open to Australian residents aged 18 years or over who; (a) are current HCF Thank You Diamond, Ruby, Emerald and Opal members; (b) have a valid HCF membership number; and (c) receive the promotional eDM, from the Promoter, inviting them to enter this promotion (**Eligible Entrants**).
4. Employees (and their immediate families) of the Promoter and agencies associated with this promotion, are ineligible to enter.   13. The best **(145) one hundred & forty five** entries as determined by HCF will win a double pass to the Sydney Comedy Festival Private comedy showcase which will be held at the Sydney Comedy Store, 122 Lang Road, Moore Park, NSW at 7.30pm on 8 May, 2018. Each double pass is valued at \$100.00.
14. If for any reason a winner does not take a prize (or an element of a prize) by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.
15. If a prize (or part of a prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification.
16. Total prize pool value is **\$14,500.00**.
17. The prize/s will be available for collection at the event venue by winners, who must bring their notification email as validation in order to collect their prize.
