

## TERMS AND CONDITIONS

# HCF CORPORATE "UP TO \$600 VIRTUAL VISA GIFT CARD REWARD OFFER FOR CORPORATE HEALTH PLAN MEMBERS"

1. The Hospitals Contribution Fund of Australia Ltd ABN 68 000 026 746 (**HCF**) is offering a \$300 Virtual Visa gift card or a \$600 Virtual Visa gift card payment (together, **reward**) if you meet the eligibility criteria in clause 4 or 5 respectively (**Offer**) on these terms and conditions. If you take the actions necessary to meet the eligibility criteria in clause 3 or 4, you agree to accept and be bound by these terms and conditions.
2. Employees (and their immediate family members) of HCF are ineligible for the Offer. An 'immediate family member' includes any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
3. This offer commences at 00:00 AEST on Monday 1 June 2026 and ends at 11:59pm AEST on Tuesday 30 June 2026 (**Offer Period**). HCF has the right to withdraw or change the Offer at any time before you take out the Singles Policy or Couples/Family Policy during the Offer Period.
4. To be eligible for this offer and receive a \$300 Virtual Visa gift card (**Eligible Person**), you must:
  - (a) be an Australian resident aged 18 years or over and you must not reside in the Northern Territory;
  - (b) during the Offer Period:
    - (i) take out HCF hospital and extras cover (excluding Ambulance only cover, HCF Corporate Care Basic Hospital, Overseas Visitors Health Cover or any partially or fully subsidised Corporate Health Cover) as a single membership under your company's Corporate Health Plan (**Singles Policy**) through:
      - (A) Corporate Sales Representatives;
      - (B) the HCF Call Centre; or
      - (C) any HCF branch; or
      - (D) your company's offer website; and
    - (ii) commence the insurance coverage under the Singles Policy; and
  - (c) pay your premium for the Singles Policy on time and within the HCF's payment terms for the first 3 months of the Singles Policy; and
  - (d) maintain the same Singles Policy for 3 months after taking out cover during the Offer Period; and
  - (e) provide a valid email address when taking out your policy during the Offer Period; and
  - (f) not have been a HCF policyholder or a partner or dependant on a HCF private health insurance policy, within the previous 2 months of the date you took out the Singles Policy.
5. To be eligible for this offer and receive a \$600 Virtual Visa gift card (**Eligible Person**), you must:
  - (a) be an Australian resident aged 18 years or over and you must not reside in the Northern Territory;
  - (b) during the Offer Period:
    - (i) take out HCF hospital and extras cover (excluding Ambulance only cover, HCF Corporate Care Basic Hospital, Overseas Visitors Health Cover or any partially or fully subsidised Corporate Health Cover) as a couples or family membership under your company's Corporate Health Plan (**Couples/Family Policy**) through:
      - (A) Corporate Sales Representatives;
      - (B) the HCF Call Centre; or
      - (C) any HCF branch; or
      - (D) your company's offer website; and

- (ii) commence the insurance coverage under the Couples/Family Policy; and
  - (c) pay your premium for the Couples/Family Policy on time and within HCF's payment terms for the first 3 months of the Couples/Family Policy; and
  - (d) maintain the same Couples/Family Policy for 3 months after taking out cover during the Offer Period; and
  - (e) provide a valid email address when taking out the Couples/Family Policy; and
  - (f) not have been a HCF policyholder or a partner or dependant on a HCF private health insurance policy, within the previous 2 months of the date you took out the Couples/Family Policy.
6. If you switch from the Singles Policy or Couples/Family Policy to another policy with HCF during the first 3 months of the policy, you will no longer be eligible for the reward.
  7. HCF will grant only one (1) Virtual Visa gift card per Singles Policy or Couples/Family Policy, and the reward is not available in conjunction with any other offer or promotion.
  8. The Virtual Visa gift card will not be awarded as cash, it will be awarded as a pre-paid e-gift card to the email address nominated by you. The Virtual Visa gift card can only be used for purchases of goods and services (except other gift cards) where pre-paid Virtual Visa gift cards are accepted and processed electronically. HCF will send an email to the email address nominated by you which will contain the prompts for you to redeem the Virtual Visa gift card. Redemption and use of the Virtual Visa gift card is subject to any terms and conditions of the gift card issuer including those specified at <https://incentivesgiftcard.com.au/terms-conditions/>. The Virtual Visa gift card will expire on the date notified to you during the redemption process.
  9. HCF may take up to six (6) weeks from the date an Eligible Person has paid their first 3 months' premium to issue the Eligible Person with their Virtual Visa gift card.
  10. If for any reason you do not redeem the Virtual Visa gift card by the time stipulated on the e-gift card, being ninety (90) days from the date of the redemption email, then the Virtual Visa gift card will be forfeited.
  11. If the reward is not available due to circumstances beyond HCF's reasonable control, HCF may substitute the reward with another similar reward determined by HCF to be of equal or higher value.
  12. Nothing in these terms limits, excludes or modifies or purports to limit, exclude or modify your rights under the Australian Consumer Law or similar consumer protection laws including under the consumer guarantees regime (**Non-Excludable Guarantees**).
  13. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, HCF (including its respective officers, employees and agents) is not responsible for and excludes all liability for any indirect or consequential loss or damage that you may suffer in connection with this Offer or use of the Virtual Visa gift card including loss of opportunity, loss of profit, personal injury or property damage.
  14. HCF collects personal information (PI) in order to conduct this Offer and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers and prize suppliers. If you do not provide (or HCF cannot otherwise collect) all of the PI requested, you will not be eligible to receive the reward. HCF will handle PI collected as part of this Offer (and more generally) in accordance with its Privacy Policy, which can be viewed at <http://www.hcf.com.au/privacy-policy/>. The Privacy Policy also contains information about how you may opt out, access, update or correct your PI, how you may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. HCF will not disclose your personal information to any entity outside of Australia.
  15. These terms and conditions will be governed by the law of New South Wales and you agree to submit to the jurisdiction of the courts of New South Wales.
  16. A term or part of a term in these terms and conditions that is illegal or unenforceable may be severed from these terms and conditions and the remaining terms or parts of the term in these terms and conditions continue in force.
